THERE ARE MANY PRIORITIES IN THE FIELD.

WE ARE MAKING BETTER PROGRESS IN SOME THAN OTHERS.

NATURALLY, THOSE WHO BELIEVE MORE STRONGLY

IN THE PRIORITIES WE HAVE NOT PROGRESSED WITH ARE DISAPPOINTED.

THOSE WHOSE PRIORITIES WE HAVE FOLLOWED ARE PLEASED.

THAT IS POLITICAL LIFE.

ONE PRIORITY WE ARE PROGRESSING WITH

IS THE HILL COMMITTEE'S RECOMMENDATION THAT PRE-SCHOOL TEACHERS
SHOULD BE TRAINED IN SPECIAL DEPARTMENTS OF PRIMARY TEACHERS
COLLEGES.

AS YOU KNOW, AN INTERIM SCHEME FOR TRAINING KINDERGARTEN TEACHERS
IS PROGRESSING WELL AT HAMILTON AND NORTH SHORE TEACHERS COLLEGES.

SIMILAR ARRANGEMENTS FOR OTHER TEACHERS COLLEGES ARE BEING CONSIDERED AND PROBABLY PALMERSTON NORTH WILL BE THE NEXT TO ESTABLISH SUCH A TRAINING PROGRAMME.

RESULTING FROM THESE STEPS TOWARDS CLOSER ASSOCIATION WITH PRIMARY TEACHER TRAINING,

THE RATE OF GRANTS PER STUDENT TO KINDERGARTEN TRAINING CENTRES

HAS BEEN INCREASED TO THE RATE APPLICABLE IN TEACHERS COLLEGES.

I HAVE ALSO RECENTLY APPROVED

PROVISION FOR KINDERGARTEN TRAINEES TO BE INCLUDED IN STUDENT
HEALTH SCHEMES.

YOU WILL KNOW OF DISCUSSIONS UNDER WAY AT PRESENT

ON THE POSSIBILITY OF ESTABLISHING REGIONAL COUNCILS OF MANAGEMENT

FOR KINDERGARTEN TEACHER TRAINING

AS SUB-COMMITTEES OF TEACHERS COLLEGE COUNCILS.

BEFORE ANY ASSOCIATION SUCH AS THIS IS SET UP

THERE WILL BE SOME AREAS OF DIFFICULTY TO BE RESOLVED

SUCH AS PARITIES IN STUDENT ALLOWANCES

LECTURERS SALARIES AND SO ON.

BUT PROGRESS IS BEING MADE AND CO-OPERATION HAS BEEN PLEASING.

EARLIER THIS YEAR YOUR UNION APPROACHED ME FOR AN INCREASE
IN YOUR ANNUAL GRANT
FOR ADMINISTRATIVE PURPOSES.

FROM THE BUDGET YOU SUPPLIED

IT SEEMS THERE ARE TWO ITEMS WHICH SHOULD BE GIVEN SPECIAL TREATMENT RATHER THAN BE INCLUDED IN THE ANNUAL GRANT TO THE UNION.

FIRSTLY THE REPRINTING OF YOUR BOOKLET
ON THE HISTORY OF THE FREE KINDERGARTEN MOVEMENT IN NEW ZEALAND.

THE ASSOCIATION ESTIMATED THIS WOULD COST \$1,200.

I AM PLEASED TO BE ABLE TO TELL YOU

I HAVE APPROVED A SPECIAL GRANT OF \$1,200 FOR THIS PURPOSE.

THE SECOND ITEM WAS AN ESTIMATED \$1,000 LOSS
ON TRAINING CENTRE OPERATING COSTS
NOT COVERED BY GOVERNMENT GRANTS.

I UNDERSTAND THAT IN DISCUSSIONS MISS INGRAM HAD WITH OFFICERS
OF MY DEPARTMENT

SHE WAS INVITED TO SUBMIT SEPARATELY

APPLICATIONS FOR TRAINING CENTRES INCURRING LOSSES.

FOR THIS REASON I DID NOT THINK IT APPROPRIATE AT THIS STAGE TO CONSIDER THIS ITEM AS PART OF THE GRANT TO THE UNION.

AS FAR AS THE NORMAL OPERATING COSTS OF THE UNION ARE CONCERNED, ON THE FIGURES YOU HAVE SUBMITTED,

I HAVE APPROVED AN INCREASE OF \$500 IN THE ANNUAL GRANT TO BRING THE TOTAL TO \$2,500 WITH EFFECT FROM 1 APRIL 1973.

I FEEL THIS IS THE MAXIMUM FIGURE I CAN APPROVE

AS IT IS IN LINE WITH THE AMOUNT GRANTED TO OTHER

EDUCATIONAL ASSOCIATIONS.

SHOULD COSTS RISE

IT MAY BE NECESSARY FOR YOUR UNION TO INCREASE THE LEVIES MADE ON THE INDIVIDUAL ASSOCIATIONS.

HOWEVER YOU WILL BE PLEASED TO KNOW

AT PRESENT I AM DISCUSSING WITH MY CABINET COLLEAGUES

FURTHER GOVERNMENT ASSISTANCE TO THE KINDERGARTEN MOVEMENT

IN THE FORM OF ADMINISTRATION COSTS OF ASSOCIATIONS

AND ASSISTANCE WITH THE RUNNING COSTS OF KINDERGARTENS.

I KNOW UNDER PRESENT POLICY

NO PAYMENT IS MADE BY GOVERNMENT

TOWARDS THE ADMINISTRATION COSTS OF ASSOCIATIONS

NOR THE RUNNING COSTS OF KINDERGARTENS.

I AM SURE YOU KNOW BETTER THAN I

THAT RECOMMENDATION 4.2 OF THE HILL REPORT

SUPPORTED ASSISTANCE TO KINDERGARTENS AND PLAY CENTRES

ON A COMMON BASIS.

THE GOVERNMENT IN ITS ELECTION MANIFESTO

AND SINCE WE HAVE BEEN IN OFFICE,

HAS GIVEN HIGH PRIORITY TO THE DEVELOPMENT OF PRE-SCHOOL EDUCATION.

WE ARE THEREFORE DISCUSSING AT PRESENT

THE POSSIBILITY OF A GRANT

FOR EACH KINDERGARTEN UNDER ASSOCIATION CONTROL.

THIS WOULD, WE KNOW,

PROVIDE MUCH NEEDED ASSISTANCE

BEING DISCUSSED ALSO AT PRESENT WITH CABINET

IS THE PROBLEM OF RUNNING COSTS OF KINDERGARTENS.

AT PRESENT AS YOU KNOW THESE COSTS ARE MET ENTIRELY BY PARENTS FROM DONATIONS OR FUND RAISING EFFORTS.

I AM PERSONALLY CONCERNED;
THAT FINANCIALLY LESS FORTUNATE COMMUNITIES

I RECENTLY APPROVED SESSIONAL GRANTS TO PLAY CENTRES
AND A SIMILAR PROPOSAL FOR KINDERGARTENS
IS PRESENTLY BEING DISCUSSED.

- THE AMOUNT WOULD PROBABLY BE NOT QUITE AS MUCH AS FOR PLAY CENTRES
 BECAUSE KINDERGARTEN TEACHERS SALARIES ARE PAID BY THE GOVERNMENT
 BUT A SESSIONAL GRANT FOR EACH HALF DAY SESSION IS BEING
 DISCUSSED.
 - I CAN OF COURSE GIVE YOU NO DECISION AT THIS STAGE
 BUT I CAN REASSURE YOU THE TWO MATTERS ARE UNDER CLOSE SCRUTINY.
 - ALSO UNDER CLOSE SCRUTINY AT PRESENT

 IS THE WHOLE QUESTION OF ASSISTANCE

 FOR BUILDINGS, FREE SITES, A 4 FOR 1 SUBSIDY

 AND FREE BUILDINGS IN AREAS OF SPECIAL NEED.
 - WE ARE SEEKING TO EASE THE BURDEN ON LOCAL PEOPLE
 IN SETTING UP AND OPERATING KINDERGARTENS IN EVERY WAY WE CAN.

WE ARE ALSO SEEKING TO ERADICATE THE LONG WAITING LISTS OF 3 YEAR OLD CHILDREN

FOR NEARLY EVERY KINDERGARTEN IN THE COUNTRY.

ONCE AGAIN I CAN ANNOUNCE NO DECISION AS YET.

- I CAN HOWEVER ANNOUNCE THE REMOVAL

 OF THE LIMITATION ON KINDERGARTEN STUDENT BURSARIES.
- FROM NEXT YEAR STUDENT BURSARIES WILL BE AWARDED TO KINDERGARTEN STUDENTS

ON THE SAME BASIS AS TO PRIMARY STUDENTS.

THEREFORE PROVIDED THE CRITERIA OF ELIGIBILITY ARE MET
THERE WILL BE NO RESTRICTION ON THE NUMBER OF KINDERGARTEN
STUDENT BURSARIES

AWARDED IN ANY ONE YEAR.

I AM CONFIDENT THAT IN THE CLIMATE OF GENERAL GOOD WILL AND CO-OPERATION

WITHIN THE PRE-SCHOOL MOVEMENTS

YOU WILL ALL WELCOME ASSISTANCE TO ANY OF THESE MOVEMENTS
BECAUSE YOU KNOW IT WILL BE HELPING OUR CHILDREN
WHICH IS OUR COMMON CAUSE.
